Credit check and credit information: I confirm that all of the information I have provided is correct and I authorise Cembra Money Bank Ltd. ("Cembra") to obtain information regarding me in connection with its review of this application and the performance of the agreement, e.g. from other companies of the Cembra Group ("Group Companies", a current list can be found at www.cembra.ch/gruppe), banks, external credit auditors, state agencies, the Central Office for Credit Information (ZEK), the Consumer Information Office (IKO) and other agencies provided for by law or otherwise, and to furnish reports to the ZEK, the IKO and, where relevant legal obligations apply, to other agencies. I acknowledge the right of the ZEK and the IKO to provide their members with information on the reported data. Any data blocks which I may order shall be deemed invalid/inapplicable with respect to Cembra. I agree that Service Providers shall be granted access to all my data that are processed in this context.

- Cembra may have my data processed in countries that do not have data protection equivalent to that in Switzerland. The data shall only be disclosed if the Service Providers have undertaken in advance to ensure an adequate level of data protection.
